About the Programme

The Executive Management Programmes Division (EMPD) of IIFT has been conceived to provide training to government officials, diplomats, entrepreneurs, exporters, corporate sector, defense personnel and civil society members to develop broader understanding of issues related to international business and its implications on trade policy. EMPD initializes programs designed to generate views, opinions, analysis on a number of contemporary trade and economic issues which are of interest to different countries particularly the developing countries.

EPGDIB aims at enhancing the managerial competence of senior and middle level executives by imparting systematic knowledge in all aspects relating to international business.

ON-CAMPUS (KOLKATA)

All the sessions would be conducted on 2^{nd} and 4^{th} weekends (Saturdays and Sundays) and will be held at IIFT, Kolkata Campus in physical mode for a period of 18 months. There will be three semesters for the programme. There will be 6 days of 'on-campus' module in each semester that will include the weekdays and weekends (other than 2^{nd} & 4^{th} Weekends). Examinations for all the Semesters would be conducted oncampus.

Minimum Eligibility Criteria

Admission to the Executive Programme will be offered by the Institute based on candidates' fulfillment of eligibility conditions and ability to synchronize programme objectives with personal career goals. Admission Process

All the applications received would be reviewed and screened. Only shortlisted candidates based on their qualifications & work experience will be informed. Extempore/Interview will be conducted for the shortlisted candidates for admission to EPGDIB (On-Campus), Kolkata. The admission to EPGDIB course is based purely on shortlisting of the candidate by the Selection Committee.

Fee Structure

- The cumulative fee for the programme is (INR 3,55,000/- + 18% GST) + INR 5,000/- which includes one-time Alumni fee.
- The Library Security Deposit is ₹ 5000 which is refundable only to students after completion of the programme.
- The participants are only responsible for payment of the programme fee (whether it is paid by the individual or by their sponsoring organization).

Course Details

- The duration of the programme (On-Campus) is 18 months (approx.).

In the event of a tie, the decision of the Programme Director (PD) will be final and all the students are required to abide by the decision of the PD irrespective of their preference.

Note I: - A student is required to opt for 7 elective courses in the III semester. Tentative list of elective courses are provided in this Brochure.

Note II: - Elective may be changed as per discretion of the Discipline Group. Students will make a choice of electives. The top preferred 7 electives will be offered to the entire class in Semester-III. Course Structure subject to revision by the Institute's Academic Council from time to time.


